M: Course Objectives/Learning Outcomes:

At the conclusion of the course, the successful student will be able to:

- 2. Define the passage of an offender through the sub-components of the Canadian criminal justice system.
- 3. Describe the structure and function of the following components of criminal justice:
 - the police
 - victim services
 - the courts
 - probation and community corrections
 - jails and penitentiaries
 - parole (federal and provincial)
- 4. Discuss Canadian crime patterns and statistics.
- 5. Identify current criminal justice issues and challenges for reform.

N: Course Content

- 1. The systems approach to the study of the Canadian Criminal Justice System.
- 2. Compiling crime statistics and determining the crime rate.
- 3. The various parts of the Canadian Criminal Justice System and the impact these parts have on the cases passing through the system.

 - the police
 - the Criminal Code of Canada and related Statutes
 - the courts
 - probation and community corrections
 - jails and penitentiaries
 - conditional release
 - parole (federal and provincial)
- 4. Current issues and challenges for reform such as:
 - the young offender
 - the aboriginal offender
 - restorative justice
 - diversity
 - fear of crime
